A RESOLUTION DIRECTING THE CSO DESK OFFICER TO CONDUCT AN INVENTORY OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF NAGA FOR THE UPDATE OF THE CSO DIRECTORY AND LEAD THE CITY'S COMPLIANCE WITH THE GUIDELINES PROVIDED UNDER DILG MC NO. 2022-083 FOR THE ACCREDITATION OF CSOs:-

WHEREAS, EO 2021-003 established the Naga City CSO Desk to, among others, mobilize and ensure participation of accredited and recognized CSOs in the various processes and activities of the City Government, as well as maintain and update the directory and database of Civil Society Organizations;

WHEREAS, EO 2021-003 also mandates the CSO Desk Officer to assist CSOs in the application for accreditation and endorse the same to the Sangguniang Panlungsod upon completion of all requirements, as provided under City Ordinance 1995-092;

WHEREAS, the DILG issued MC No. 2022-083 to provide guidelines on the accreditation of Civil Society Organizations and selection of representatives to the Local Special Bodies;

WHEREAS, the Memorandum Circular is very instructive as to need for LGUs to be guided in the accreditation of CSOs and the important role of the CSO Desk Officer in the conduct of the inventory and the over-all accreditation process;

NOW THEREFORE, on motion of the Hon. Ghiel G. Rosales, seconded by Hon. Jessie R. Albeus, Hon. Joselito S.A. del Rosario and Hon. Vidal P. Castillo;

BE IT RESOLVED, to direct the CSO Desk Officer to conduct an inventory and update the directory of Civil Society Organizations;

RESOLVED FURTHER that the CSO Desk Officer is further directed to submit a regular compliance and status report of guidelines issued by the DILG under Memorandum Circular 2022-083.
